

CERTIFICATION OF TRUST
(Pursuant to California Probate Code § 18100.5)

I, JOHN C. SAMPLE and JOAN C. SAMPLE, Trustee(s) confirm the following facts:

1. THE SAMPLE REVOCABLE LIVING TRUST (Name of Trust) is currently in existence and was executed on [NOTARY DATE].
2. The Trustors of the trust are: JOHN C. SAMPLE and JOAN C. SAMPLE.
3. The currently acting Trustee(s) of the trust is (are): JOHN C. SAMPLE and JOAN C. SAMPLE.
4. The power of the Trustee(s) includes:

The Trustee shall have, in general, the power to do and perform any and all acts and things in relation to the trust fund in the same manner and to the same extent as an individual might or could do with respect to his or her own property including the power to buy, sell, hold, transfer, convey, or exercise any ownership rights in any asset for the Trust by executing any appropriate document, or by an oral demand to buy or sell a security; to maintain, deposit or to withdraw from any bank, brokerage or mutual fund account (including margin accounts), and to sign checks or drafts on any such account; to purchase or exercise rights in any life insurance or annuity contracts; and to borrow and pledge any Trust asset as security. In addition to the above, the Trustee shall have all of the powers enabled by §§16200, et. seq., of the California Probate Code (as though such powers were set forth herein) and, in addition, the Trustee is specifically authorized and empowered to exercise those powers set forth in the Trust.

No specific provision of the Trust limits the general authority of the Trustee granted in the Trust and outlined above. Further, the Trust is not subject to supervision by any court nor is court permission or approval necessary for any act by the Trustee.

5. The trust is REVOCABLE and the following party(ies), if any, is (are) identified as having the power to revoke the trust: JOHN C. SAMPLE and JOAN C. SAMPLE.
6. The trust DOES have multiple Trustees.
7. The Trust uses the Social Security number of either Trustor as its Taxpayer Identification Number. No separate tax identification number is required while this Trust is revocable and the Trustors or either of them is acting as Trustee.
8. Title to trust assets are to be taken in the following manner: THE SAMPLE REVOCABLE LIVING TRUST.
9. The trust has not been revoked, modified, or amended in any manner that would cause the representations in this certification to be incorrect.
10. Either trustee acting alone may take any action on behalf of the trust, except that the sale or encumbrance of real property requires the signatures of both trustees.
11. ADMINISTRATIVE PROVISIONS: The Trust shall be administered according to the California Trust Code (Division 9 of the California Probate Code beginning with §15000), except as shall be specifically modified therein.

(a) This Certification of Trust is a true and accurate statement of the matters referred to herein concerning the Trust.

(b) This Certification of Trust has been signed by both of the currently acting co-Trustees of the Trust.

(c) This Certification of Trust is intended to comply with the provisions of §18100.5 of the California Probate Code.

(d) Reproductions of this executed original (with reproduced signatures) shall be deemed to be original counterparts of this Certification of Trust and any person who is in possession of a photocopy of this executed Certification may, in good faith, rely upon the information it contains and shall not be liable to the Trustors, any Trustee or beneficiary for reliance upon the information herein contained.
